*Taxation literally counterbalances government spending by reclaiming all or part of it from the economy. But what it never does is pay for the spending in the first place because any government can spend without tax. Previously, HMRC has given taxpayers the opportunity to report tax on any undeclared income. *Clients with business interests and personal wealth in the US and the UK are required to navigate two complex and very different tax systems. Successful wealth planning for such clients requires the lead advisor to be "ambidextrous" in that they understand the tax treatment of a proposed transaction in both countries simultaneously. Barristers need to have good powers of persuasion, whether oral or written, and to be able to explain complex issues so that their clients, members of a jury or other non-specialists are able to follow the argument clearly. Accomplished tax experts could advise on any aspects of general law which impinge on an transaction. Tax barristers strategise, analyse and argue about words and their meanings, about what really happened v what might appear to have happened, and about how best to look after the clients. Individuals and firms should be able to undertake legitimate tax planning. However, where specialist advisers are deployed on unusual and creative schemes, tax planning can be deemed to move beyond legitimate avoidance. *Many a barrister deals with HMRC enquiries and tax appeals to advising entities in relation to risk assessments for the purposes of the Criminal Finances Act 2017.
